WHEREAS, John Denney, Superintendent, Hanover-Horton School District, has, pursuant to the Michigan Teachers' Tenure Act, filed charges dated August 22, 2019 with the Secretary of the Board of Education against Johnnie Stewart, a tenured teacher employed by the Hanover-Horton School District; and

WHEREAS, this Board of Education has a duty under Article IV, Section 2, of the Michigan Teachers' Tenure Act to determine whether to proceed on the charges.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Board of Education hereby determines to proceed on the charges and orders the Secretary of the Board of Education to cause to be furnished to Mr. Johnnie Stewart a copy of the charges now on file with the Board of Education and to inform Mr. Johnnie Stewart of his rights under Article IV of the Michigan Teachers' Tenure Act, including a right to contest the

Board of Education's decision to proceed on the charges by filing a claim of appeal with the Tenure Commission not later than twenty (20) days after receipt of this Board of Education's decision to proceed, and a right to a hearing, either public or private, at the teacher's option, before an Administrative Law Judge.

- 2. The Administration is authorized to assist the Secretary of the Board of Education in effecting the above notice to Mr. Johnnie Stewart.
- 3. Mr. Stewart is hereby suspended with pay from active performance of duty until one of the following occurs:
 - (a) He fails to contest the decision to proceed upon the charges within the twenty (20) day time period specified above.
 - (b) A preliminary decision and order discharging or demoting him is issued by the Administrative Law Judge, under Article IV, Section 4(5)(i) of the Tenure Act.
 - (c) If the preliminary decision and order is to reinstate Mr. Stewart, a final decision and order is rendered by the Tenure Commission under Article IV, Section 4(5)(m) of the Tenure Act.
- 4. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be and the same are hereby rescinded.
