### **Reconfirmation Meeting for November 2020**

#### Reconfirm instructional delivery method:

Hanover-Horton School District is offering two learning plans for our students during the 2020-2021 school year while Michigan is operating in either Phase 4 or Phase 5. Our program will easily allow us to transition to a fully online program if we are moved to Phase 3 or fully in-person learning if chosen upon being moved to Phase 6. Students are able to choose a full-time online track, or they may participate in our program which offers four days per week at school with each Wednesday utilizing remote learning in order to accommodate cleaning our facilities and provide teachers with necessary time to take care of the added responsibilities of the dual learning modes.

Students working remotely will be completing the same assignments as our students participating in person. Our teachers will be utilizing Google Classroom or Seesaw to share lessons with our online students; both formats allow materials to be downloaded. Knowing that internet connectivity is a potential issue for many of our students, all of our essential work is able to be downloaded to devices in order for work to be completed offline. Students who need a device to complete online assignments will be provided with either a Chromebook or iPad depending on their grade level. Online students are encouraged to maintain a similar pace of work completion as our in-person learners in order to accommodate their ability to be able to return to class without any learning gaps.

# Reconfirm how instruction will be delivered for each grade level:

Elementary (Grades K - 5): All in-person learners will receive instruction from their teachers. Assignments may be completed using Seesaw or Google Classroom. All online students will receive instruction via teacher supplied videos or other supplemental material while using either Seesaw or Google Classroom.

Middle School (Grades 6 - 8): All in-person learners will receive instruction from their teachers. Assignments may be completed using Google Classroom. All online students will receive instruction via teacher supplied videos or other supplemental material while using either Google Classroom.

High School (Grades 9 - 12): All in-person learners will receive instruction from their teachers. Assignments may be completed using Google Classroom. All online students will receive instruction via teacher supplied videos or other supplemental material while using either Google Classroom.

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

We do not have any students listed as English language learners. There are 71 special education students attending in person and 33 utilizing our online learning option.

#### **Document Public Comments:**

An elementary teacher commented that:

- It is very difficult to get packets/materials ready for students when there is short notice of students/staff going on quarantine.
- Questioned whether our learning plan stayed the same if Michigan has no phases regarding COVID. We still have phases, and our plans have not changed. Michigan is still currently in Phase 4.
- It is best for all students to attend school in person.

Another elementary teacher questioned whether the district had plans to do an all-call to families as a gentle reminder regarding the guidelines around Thanksgiving travel. The district will send out a reminder, with health department guidelines. Also, is there any discussion among county superintendents on taking a break between Thanksgiving and Christmas? Superintendents will meet soon and there will be more discussion on that topic.
