

## **Hanover-Horton School District Student Screening Requirements**

Before leaving for school, make sure to complete the following screening for every student in your household. If your student has any of the following symptoms, that indicates a possible illness that may decrease the student's ability to learn and puts them at risk for spreading illness to others.

### **MARK ALL THAT APPLY IN SECTION ONE AND TWO:**

#### **Section One: Symptoms**

- Temperature 100.4 degrees Fahrenheit or higher
- Sore throat
- New uncontrolled cough that causes difficulty breathing (for students with chronic allergic/asthmatic cough, a change in their cough from baseline)
- Diarrhea, vomiting, or abdominal pain
- New onset of severe headache, especially with a fever
- New onset of loss/change in taste or smell

#### **Section Two: Close Contact/Potential Exposure**

In the past 14 days has your child:

- Had close contact (within 6 feet of an infected person for at least 15 minutes) with a person with confirmed COVID-19:

OR

- Had close contact (within 6 feet of an individual for at least 15 minutes) with a person under quarantine for possible exposure to COVID -19

### **NEXT STEPS:**

- If the answer is YES to any of the symptom questions, keep your student(s) home from school.
- If the answer is YES to any symptoms question and YES to any close contact/potential exposure question or live in an area with high levels of COVID-19 in the community, call the school as soon as possible to let them know the reason your student(s) won't be there today. Call your healthcare provider right away. If you don't have one or cannot be seen, contact the Henry Ford Allegiance Health Covid Screening Department at (517)205-6100, the Center for Family Health at (517)748-5363, or the Jackson County Health Department at (517)788-4428 (option 9).
- If the answer is YES to any of the symptom questions, but NO to any close contact/potential exposure questions, your student may return based on the guidance for their symptoms:
  - ★ Fever: at least 24 hours have passed with no fever, without the use of fever-reducing medications
  - ★ Sore throat: improvement (if strep throat: do not return until at least 2 doses of antibiotic have been taken)
  - ★ Cough/Shortness of breath: improvement
  - ★ Diarrhea, vomiting, abdominal pain: no diarrhea or vomiting for 24 hours
  - ★ Severe headache: improvement

⇒ *(EXCEPTION) If there is a sudden loss of taste or smell they will need to receive a COVID Test.*
- If the answer is NO to any of the symptom questions (Section One) and YES to any of the questions regarding close contact/potential exposure in (Section Two), your student(s) MUST quarantine for 10 days at home and notify the school of the reason for their absence. Accommodations for online learning may be made to keep your student from falling behind.
